

## **OPERATION INSTRUCTIONS**

Remove the rubber cover from the battery box to install or replace batteries and to adjust operational settings. Re-attach the rubber cover to the battery box for Operation. DO NOT operate the product outdoors without the Rubber Cover securely attached to the Battery Box.

This switch will only activate lights and sound when the sensor is activated **SENSOR** (Lights will flash in sync to the sound for one audio-cycle with each sensor activation).

O This switch mode will turn the lights and sounds off.

I This switch mode will continuously operate the lights and sound of the item.

Raise or lower the volume using the volume control turn dial, turn all the way down to turn the volume off.

## BATTERY REPLACEMENT INSTRUCTIONS

- \* Requires 3 x AA (1.5V) batteries (Not Included).
- \* You will need a small Phillips head screwdriver (Not Included).

Locate the battery compartment on the product. Remove the battery compartment cover by using a small Phillips head screwdriver to unscrew the screw. After removing or installing the batteries, place the battery compartment cover into position, and secure the battery cover. DO NOT overtighten screws.
